Introduction

Since 2007, the HIV in Europe initiative has been dedicated to improving earlier diagnosis and care for HIV throughout the European Region and has provided a European platform for the exchange of research findings and the promotion of related activities. The initiative has played a critical role in the HIV response by uniting clinicians, community activists, policymakers and researchers to ensure that people living with HIV are diagnosed early and linked to care and treatment.

Since 2014, the work of the initiative has also encompassed testing for hepatitis B and C, given the many interlinkages and institutionalised with the HepHIV Conferences (Barcelona 2014, Malta 2017, Bucharest 2019). During 2018, the initiative's Steering Committee committed to expanding the scope of the initiative to encompass the tendency to address infectious diseases more broadly and less disease specific due to the overlap in transmission routes and most-affected populations, reflected also in the EU policy framework on HIV/AIDS, TB and hepatitis – and the Joint Action Integrating prevention, testing and linkage to care strategies across HIV, viral hepatitis, TB and STIs in Europe (INTEGRATE) www.integrateja.eu.

The impact of late diagnosis on individuals and health systems remains an urgent problem in Europe.

Undiagnosed HIV and viral hepatitis – as well as tuberculosis (TB), causes unnecessary morbidity and mortality for the affected individual and involves an increased risk of unintentional transmission. Despite the knowledge that earlier testing and care is cost-effective, too many individuals still get diagnosed far too late.

The decision was made by the Steering Committee to rename HIV in Europe to *EuroTEST - Working together for integrated testing and earlier care* and broaden the initiative's scope of work to include sexually transmitted infections (STIs) and TB. The overall objective of the initiative remains the same with a focus on testing – in combination when appropriate for HIV, hepatitis B and C, TB and STIs. The name change was announced during the HepHIV 2019 Conference in January 2019.



The initiative is directed by the Steering Committee, which is an independent group of experts who represent civil

society, research institutions, policy bodies, health systems and public health institutions. It is led by one co-chair who is a clinician and one who is a community representative. There are also several observers, from the WHO Regional Office for Europe, the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA), the European Centre for Disease Prevention and Control (ECDC) and Hepatitis B & C Public Policy Association.

The Policy Secretariat of the EuroTEST Initiative is based with the European AIDS Treatment Group (EATG) and the Secretariat, which oversees the day-to-day running of EuroTEST and its various projects, is based within CHIP, Centre of Excellence for Health, Immunity and Infections at Rigshospitalet in Copenhagen.

Since its initiation, the initiative has obtained support from industry sponsors to conduct its activities, underwrite the biennial conferences, and to focus on activities in the Eastern European region, and in recent years the European Commission has been a major co-funder of EuroTEST activities.





Activities and status of projects and results in 2018

Joint Action on integrating prevention, testing and link to care strategies across HIV, viral hepatitis, TB and STIs in Europe (INTEGRATE)

The EuroTEST secretariat (CHIP/RegionH) coordinates the Joint Action on integrating prevention, testing and link to care strategies across HIV, viral hepatitis, TB and STIs in Europe - INTEGRATE. INTEGRATE runs over three years (September 2017-August 2020) and the budget is 2.5 Million EUR with an 80% co-funding from the 3rd EU Health Programme. INTEGRATE unites 29 partners from 16 countries (Croatia, Denmark, Estonia, Greece, Hungary, Ireland, Italy, Lithuania, Malta, Poland, Romania, Serbia, Slovakia, Slovenia, Spain, and UK). The partners are public health institutions, hospitals (infectious disease and research departments), NGOs and universities. The main objective of INTEGRATE is to integrate early diagnosis and linkage to prevention and care of HIV, viral hepatitis, TB and STIs in EU member states by 2020. INTEGRATE focuses on how effective tools for diagnosis and linkage to care in one disease area can be used in others.

INTEGRATE is building on activities from OptTEST, Euro HIVEdat, HepCARE, E-detect-TB, EuroTEST and other relevant EU projects and EU institutions working with HIV, Hepatitis, TB and STIs testing and linkage to care.

INTEGRATE provides a platform to disseminate and exchange best practice among European countries and facilitate discussions on innovations and emerging issues within the four diseases. In this respect, INTEGRATE is a shared European effort that extends beyond the partners and can create important synergies across European stakeholders, projects and initiatives.

During 2018, progress was achieved throughout the different INTEGRATE work streams and including:

- General administrative and coordination structures have been set up incl. development of project profile i.e. logo, webpage, internal portal, social media presence (FB and Twitter), document templates and newsletters.
- The mappings and literature reviews on the main topics in core work packages partner notification, self-testing, ICT-tools, integrated testing, national surveillance integration of data have been finalised and have also been used in the planning of pilots. The first yearly internal evaluation has been conducted with overall very positive feedback from partners.
- In the work with integrating testing and linkage to care 6 partners in Lithuania, Slovakia, Italy and Croatia and 2 collaborating stakeholders in Greece and Portugal have piloted a Spring European Testing Week (May 2018) in collaboration with the European Liver Patients' Association aiming at integrating activities for hepatitis and HIV. 1870+ tests were conducted in the organisations during that week. The protocol for pilots in Indicator Condition Guided testing has been translated into Romanian and Lithuanian and pilots have started in Romania and Lithuania. Work on mapping the status of self/home-testing across Europe and a literature review was conducted.
- In the work with improving the use of Information Communication Technology (ICT) tools and Partner Notification, a thorough review was conducted and out of 115 ICT tools identified, 53 tools were evaluated, and 7 tools shortlisted for the INTEGRATE ICT tool which will be developed during year 2.
- Organisation of Satellite Symposium in conjunction with the AIDS 2018 conference in Amsterdam, entitled "HIV and co-infections in at-risk populations addressing cross-border treatment needs and ensuring earlier diagnosis for migrants, the homeless, prisoners and other vulnerable populations"

European Testing Week (ETW)

The pilot Spring European Testing Week, which occurred from 18-25 May 2018, was conducted in collaboration with ELPA and INTEGRATE with a focus on integrated testing for HIV and Hepatitis and increasing access for most-affect population groups. The main aim was to assess the feasibility and





sustainability of conducting two testing weeks in a year and to increase combined HIV-Hepatitis testing among most-affected populations, raise awareness and increase access to testing. There was focus on combined testing for HIV and Hepatitis; and a special focus on SW and PWID. Though notification of the Spring ETW was on short notice, 104 organisations in 47 countries from the WHO European region managed to sign up and conduct activities during the Spring ETW. Results from the post-Spring ETW pilot evaluation survey showed that most respondents (76%) reported doing activities for the general population (however respondents could identify more than one targeted population) and 33% reported conducting combined testing activities for HIV, HCV and HBV. Overall, the Spring pilot was successful and about 73% of the survey respondents reported that they were likely to participate in more than one ETW a year.

The start of the Autumn (November) ETW was marked by the release of the new ECDC testing guidance, which highly emphasised the importance of integrated HIV and viral hepatitis testing activities. At the end of the November 2018 ETW, there were 749 signed-up organisations (68 completely new to ETW). After each ETW, each signed-up organisation is asked to complete a post-ETW online survey. Respondents from the post-November 2018 ETW evaluation survey reported targeting their ETW activities for the general population. MSM, and young populations, however, respondents were able to select more than one target population. Respondents also reported conducting ETW activities for HIV, HCV and HBV. For the first time, respondents were able to indicate if they conducted activities for other conditions including STIs (chlamydia, gonorrhoea and syphilis) and tuberculosis. The number of respondents who reported doing single disease activities decreased from 50% in 2017 to 34%, while the amount who reported combined activities (targeting more than one disease) increased from 50% in 2017 to 66% in 2018.

HIV and hepatitis testing guidance in the EU/EEA

In a consortium with Public Health England (PHE), St Stephen's AIDS Trust (SSAT)/Chelsea and Westminster Hospital NHS Foundation Trust and the European AIDS Treatment Group (EATG), the EuroTEST Secretariat (CHIP/RegionH) coordinated the development of an evidence-based public health guidance on integrated HBV, HCV, and HIV testing in the EU/EEA commissioned by the European Centre for Disease Prevention and Control (ECDC). The development of the guidance included a systematic literature review of the latest evidence and input from a panel of European experts in the fields of HIV and viral hepatitis.

This project ran over three years (2016-2018) with a budget of 240.000 Euro, and it drew on a previous evaluation conducted in 2015-2016 by the same consortium on the impact and effectiveness of the 2010 ECDC HIV testing guidance.

The <u>integrated guidance</u> was published 23 November 2018 in conjunction with the start of the Autumn European Testing Week.

The guidance supports countries in the global effort to combat viral hepatitis and eliminate HIV as public health threats by 2030. The ECDC guidance advocates for the development of an integrated national testing strategy to combat all three infections, targeting most-affected population groups and outlines where, how and when to test by providing evidence-based strategies already implemented.

The HIV & HCV Testing Resource Centre

Since 2016, EuroTEST has had an online resource centre of peer-reviewed scientific articles on HIV and HCV testing and national HIV and HCV testing guidelines in the 53 countries of the WHO European Region on the <u>EuroTEST website</u>. This is continuously updated and maintained to provide up to date and relevant information and resources to those interested in testing and linkage to care.

During 2018, EuroTEST continued to gather and analyse national HCV testing guidelines to map the current situation across Europe in terms of HCV testing (where people can test; who can conduct the testing), and a manuscript for publication is being drafted. Search strings through Medline, EMBASE and Google Scholar





were run, and relevant guidelines and articles were uploaded to the Resource Centre. Additional searched resources included websites for national Ministries of Health, national HIV testing guidelines provided by coordinators in OptTEST Work Package 5 and respondent answers to the survey evaluation of the 2010 ECDC HIV public health guidance.

New Initiatives & Future Plans

EuroTEST - Consolidation of new name

Since the name change announcement at the HepHIV2019 conference, information on the renaming will be communicated and disseminated to sponsors, endorsers and other stakeholders. Plans to expand the EuroTEST SC to include members representing the 'new' diseases (TB, STIs and hepatitis) in addition to engaging in projects and initiatives that focus on TB, STIs and/or hepatitis.

HepHIV Conference 2019

During 2018, important efforts were put into planning the HepHIV 2019 conference in collaboration with the INTEGRATE JA. The conference, running under the theme 'Challenges of Timely and Integrated Testing and Care', was held 28-30 January 2019 in Bucharest under the Romanian EU presidency. Over 200 people attended, and 70 abstracts were submitted to the conference. The main objectives of the HepHIV 2019 conference were to:

- Provide an overview of innovative initiatives and best practices on optimal testing and earlier care for HIV and viral hepatitis from different settings across Europe, including progress and challenges in the integration of services.
- Provide opportunities for multi-stakeholder dialogue to develop creative solutions to unresolved challenges in research and implementation of HIV and viral hepatitis, TB and STI policies and programmes to improve early diagnosis and care.
- Sustain and fuel the political discussion of testing policies, increase political commitment and public awareness by discussing how to translate global and regional goals, objectives and targets into local implementation plans.

Based on the conference presentations a <u>call to action</u> addressing implications for policy and implementation agendas in the field of earlier and integrated testing is currently being drafted.

ETW

The second Spring European Testing Week will be held again from 17-24 May 2019 in collaboration again with ELPA and Integrate – now as an established campaign week.

In collaboration the ETW Working Group and Integrate partners are developing an educational and training component with focus on integrated testing in community settings to increase combined testing efforts and access to testing.

These educational initiatives will be conducted through webinars and three country meetings in collaboration with INTEGRATE partners in Croatia, Greece, Lithuania. The country meetings aim to bring together relevant stakeholders from policy and national surveillance institutions, clinical settings and community organisations involved in the continuum of care for people living with HIV (viral hepatitis, TB and STIs) to better understand local experiences and engage stakeholders in a national effort to identify gaps and seek solutions and synergies between all levels.





INTEGRATE

For the next pilot testing activities in Integrate, the first step is to develop an audit tool (online survey) for detailed baseline data on testing practices conducted by Integrate partners. Data collected from the audit tool will serve as a baseline for the pilot interventions focusing on enhancing integrated testing.

There will also be three regional workshops to implement capacity building of JA partners and national stakeholders (CSOs, health care professionals, public health care agencies, etc.) to provide training and education in the areas of integrated testing in community services, IC-guided testing in health care settings and the use of patient experience surveys for service improvement. The regional workshops are planned for Poland (June 2019), Italy (November 2019) and Estonia (May 2020).

Hepatitis late presentation

A proposal for a pilot project to apply the definition for late presentation of viral hepatitis has been developed and applications for funding will be conducted.

Diagnostic technologies projects

A new project proposal will be developed focusing on diagnostic technologies in community settings. It would cover several aspects:

- A survey among testing sites to examine diagnostic algorithms for POC diagnostics to see what has been done in campaigning across Europe to encourage testing (especially for hepatitis and syphilis).
- Develop tools to support enhanced screening for active syphilis in community settings.
- Explore opportunities for joint procurement among Checkpoints for point of care (POC) tools.

ECDC Literature Review on HIV prevalence rates (TBC)

EuroTEST has submitted a proposal to ECDC in response to a tender on mapping HIV seroprevalence rates in key populations across the EU/EEA based on a systematic literature review and mapping. Project initiation is planned for early Spring 2019 (TBC).





Policy and advocacy status and results in 2018

The Advocacy Secretariat of the EuroTEST Initiative is based with the European AIDS Treatment Group (EATG). EATG advocates for optimal testing and care for the EuroTEST Initiative and promotes its projects and achievements.

Advocated for increased political attention to HIV and co-infections and investment in targeted services for main affected groups in the last year aimed at securing the adoption of a European Commission policy framework to improve the European response to HIV/AIDS, as well as viral hepatitis and tuberculosis coinfections across the continent. The secretariat also advocated for a strong EU presence at AIDS 2018 conference in Amsterdam. Through the Civil Society Forum on HIV, TB and viral hepatitis (CSF) it engaged with the European Commission services and agencies. At AIDS 2018, the European Commission launched a Staff Working Document on HIV, TB, viral hepatitis and STIs, which provides an integrated analysis of the situation and policy instruments. It also highlights best practices on testing and linkage to care. Within the civil society zone of AIDS 2018, the secretariat organised sessions at the European NGOs booth. These provided a platform for exchange between stakeholders on policy work and tools to achieve earlier diagnosis and treatment, as well as the integration of services. These sessions have included representatives from EuroTEST, WHO, EACS, the European Commission and EMCDDA and community groups across Europe. Tools from the OptTEST project by HiE were disseminated at the booth. The Secretariat also took part in a session at the EU booth on European Testing Week. EuroTEST was represented in several policy sessions at the AIDS 2018 conference, including at the EU-UNAIDS symposia with European ministers of health at the AIDS 2018 discussion on innovations in Europe to end AIDS.

The May and November meetings of the <u>Civil Society Forum</u> on HIV, TB and viral Hepatitis and Think Tank addressed testing strategies and barriers, with updates on testing regulations, an initiative on promoting HCV testing in drug treatment settings (EMCDDA), testing and treatment in prison settings (EMCDDA and ECDC). In November, at the Think Tank, member states provided feedback on European Testing Week.

In September, EuroTEST and EATG collaborated for a European Community Advisory Board meeting with community testing services providers, partners and diagnostics companies. The meeting started by a training by UNITAID on testing technologies for use in community settings. It was followed by an exchange on community testing approaches, challenges and needs. The meeting was then devoted to a dialogue between community and individual manufacturers on testing technologies, gaps and barriers to their use. Beyond individual testing tools, participants addressed the need for collaboration to simplify testing procedures, to integrate of testing and to identify the package of services to be provided. This discussion was to be followed at the HepHIV conference in 2019.

The advocacy secretariat has also worked on strengthening the capacity of communities to address legal and regulatory barriers to testing and treatment effectively, drawing on materials developed by EuroTEST. For instance, in June, EATG's training for new treatment advocates (STEP UP) addressed testing used the OptTEST advocacy toolkit. In July, materials were used in M-CARE training module focused on migrants.
